

RESEARCH AND PUBLICATION MISCONDUCT

refer to unethical or improper conduct that undermines the integrity, credibility, and reliability of research findings. These can take various forms and may occur at any stage of the research process. Research misconduct encompasses actions such as fabrication, falsification, plagiarism, etc., striking at the core of scientific integrity. Often, research misconduct is a wilful act with ulterior motives. Research misconduct or malpractice can have far-reaching consequences that impact various aspects of one's personal life and career, the funders, the scientific community, academia, and society as a whole. This article explores some common research misconducts by individuals and publishers.

Falsification

Manipulating research data, images, or results to present false or misleading findings is considered

refer to unethical or improper conduct that undermines the integrity, credibility, and reliability of any stage of the research process. onduct encompasses actions such as isification, plagiarism, etc., striking at a wilful act with ulterior motives.

falsification of data. This may involve selectively excluding or altering data points, fabricating experimental results, or misrepresenting statistical analyses. Falsified data can lead to erroneous conclusions, which can misinform scientific understanding and potentially harm individuals or society if acted upon. Falsification damages the trustworthiness of researchers, institutions, and the scientific community as a whole. It undermines confidence in the reliability and credibility of research findings.

Fabrication

Similar to falsification, fabrication of research involves inventing or concocting data, experiments, or findings that do not exist. This may involve creating fictitious research subjects, experiments, or results to support a desired hypothesis or conclusion. Fabricating data violates fundamental principles of research integrity, honesty, and transparency. It undermines the trustworthiness of scientific inquiry and compromises the integrity of the research



process. Fabrication misrepresents the reality of the observed phenomenon, leading to false conclusions and potentially harmful actions or decisions based on those conclusions.

P-Hacking

A grey area of scientific research practice and often pervasive that undermines the ethical scientific research and conduct is called p-hacking. It is also known by different names such as data dredging, data grubbing, data butchery, data fishing, selective inference, significance chasing, and significance questing. P-hacking involves researchers collecting or selecting data or statistical analyses until non-significant results become significant. In other words, p-hacking involves cherry-picking method of culling important and reliable data till a desired result is achieved. This practice often gives rise to false positive which misleads or misinforms readers and information users.

Plagiarism

Presenting someone else's ideas, words, or work as one's own without proper attribution. This includes copying verbatim text from sources without quotation marks or citations, paraphrasing content without proper acknowledgement, or using ideas without permission. In academic settings, plagiarism can lead to severe penalties, including failing grades, expulsion from educational institutions, or revocation of academic degrees. It undermines the integrity of the educational process and devalues the efforts of honest students.

Duplicate or Redundant Publication

The publication of the same research findings in multiple journals or venues without proper disclosure or acknowledgement is considered a duplicate or redundant publication. This includes submitting substantially similar manuscripts to different journals simultaneously or republishing previously published work without permission. Duplicate publication distorts the scientific record by artificially inflating the apparent significance or impact of research findings. It can create a false impression of consensus or corroborating evidence where none exists, leading to misinterpretation of scientific literature.

Salami Slicing

Also called least publishable unit (LPU), is a deceptive practice in academic publishing where researchers divide research findings into multiple smaller publications to artificially inflate publication metrics or enhance academic credentials. This practice involves publishing incremental or marginal results as separate papers rather than integrating them into a single comprehensive study. By breaking down research into smaller units, salami slicing dilutes the scientific contributions of the work. It fragments knowledge and makes it more difficult for readers to understand the full context and implications of the research.

Conflict of Interest

Failing to disclose or manage conflicts of interest (COI) that could influence the objectivity, integrity, or impartiality of research. This includes financial, personal, or professional relationships that could bias research findings or compromise ethical standards. Conflict of interest occurs when an individual or entity has competing interests that could potentially bias their actions, decisions, or judgments in a way that undermines their impartiality, objectivity, or integrity. COI can arise in various contexts, including academic research, professional relationships, business transactions, and public policymaking.

Ethical Violations

Ethical violations include a range of research misconduct and practices that violate ethical princi-

ples or regulatory requirements. This may include conducting research without proper informed consent, failing to protect the rights and welfare of research participants, or disregarding ethical guidelines for research involving human or animal subjects.

Retraction Evasion

Resisting or delaying the retraction of research publications found to contain fraudulent or erroneous data. This may involve ignoring requests for retraction, obstructing investigations into research misconduct, or attempting to discredit or intimidate whistleblowers. Failure to retract flawed or fraudulent research allows misinformation to persist within the scientific literature, potentially misleading other researchers, professionals, policymakers, and the public. This perpetuates inaccuracies and can have detrimental effects on subsequent research, decision-making, and public trust in science.

Peer Review Manipulation

Manipulation of the peer review process is done to influence the acceptance or rejection of manuscripts. This may involve collusion with reviewers, submitting fraudulent reviews, or coercing editors or reviewers to favourably review or publish research. Peer review manipulation can lead to the acceptance of low-quality or flawed research papers, as unethical tactics may bypass critical evaluation of the scientific merit, validity, and reliability of the research. This compromises the integrity and credibility of the academic literature.

Misrepresentation of Credentials

Falsifying academic or professional credentials, affiliations, or qualifications is considered a misrepresentation of credentials. This is a practice to gain research funding, employment, or recognition. This may involve claiming degrees, certifications, or honours that have not been earned or misrepresenting institutional affiliations or positions or flimsy or superficial association with institutions.

Wrong Attribution of Authorship

Wrong attribution of authorship, also known as authorship misconduct, occurs when individuals are credited as authors of a research publication with-



out meeting the criteria for authorship or without their consent. This can take several forms and may involve both intentional and unintentional actions. Wrong attribution includes ghost authorship, honorary authorship, etc.

Wrong Citation

Wrong citation, also known as citation manipulation or citation fraud, occurs when references are inaccurately or dishonestly cited in research publications. This can take various forms and may involve intentional or unintentional actions. The wrong citation also includes self-citation, mutual citation and preferential citation to inflate the citation count.

Research misconduct undermines the integrity of scientific inquiry, eroding public trust and impeding progress. Fabrication, falsification, and plagiarism not only distort findings but also waste resources and misdirect future investigations. Addressing misconduct demands robust policies, transparent oversight, and a culture of ethical accountability. Vigilance against such practices is essential to maintain the credibility of research and ensure the advancement of knowledge for the betterment of society. Ultimately, fostering an environment of honesty and integrity is paramount to upholding the principles of scientific inquiry and safeguarding the integrity of the academic community.

It begins by explaining JDBC's role as a Java-based data access technology that allows developers to seamlessly connect Java applications to various data sources, including relational databases. This API is part of the Java Standard Edition and requires a JDBC driver specific to the database being accessed.

The lecture also outlines the standard steps required to connect a Java application to a database using JDBC: registering the driver class, creating a connection, generating a statement, executing queries, and finally, closing the connection. This process is illustrated with practical examples for connecting to both MySQL and Oracle databases, providing the necessary syntax for driver classes, connection URLs, and SQL statements.
